We live at 21 Pendle Road and have previously rented 19 Pendle Road unfurnished as long-term lets.

19 Pendle Road would be commercially let for profit and available for a letting as furnished holiday accommodation for at least 210 days in the year.

We expect the property will be let for a minimum of 105 days per year.

The property is a two-bedroom mid terrace house next door to our home which is an end of terrace property.

We expect most lettings to be to two adults.

There are two bedrooms, one with a double bed and the other with a single bed and a single fold out bed. The maximum number of occupants will be four people.

We will not be letting to larger groups to avoid nuisance/noise from groups such as stag/hen parties.

Parking will be available for customers at the side of our house on our private drive which has room for three cars. We own one car and therefore can accommodate two cars from anyone staying at the rental property.
