T1-Cypress-Poor form and unsuitable species for location, of low retention value-Remove and re-plant with suitable broadleaf species such as Rowan
T2-Beech-Prune to provide a clearance of 4m from property roof
T3-Beech-Prune to provide a clearance of 4m from property roof
T4-Laurel-Low amenity value-Remove and re-plant with suitable broadleaf species such as Crab Apple
T5-Beech-Bark inclusion at circa 2m-Crown raise over highway and reduce secondary leader over highway to reduce future risk of major failure
T6-Lime-Prune to provide clearance over highway and clear utility lines
T7-Holly-Fell and re-plant with Yew-Of poor suppressed form
T8-Cherry Plum-In severe decline-remove and re-plant with broadleaf of suitable species for location
T9-Ash-Dead-Remove
T10-Holly-Poor suppressedform-remove and re-plant same species
G2-Group of 4 Conifers-Causing excessive shading and of low amenity value-Fell and re-plant with suitable broadleaf species for location (Birch,apple etc)

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
