The proposed change of use from a retail premises to a small bar at 91 Berry Lane, Longridge, Lancashire, PR3 3WH has been assessed against the statutory Biodiversity Net Gain (BNG) requirements introduced under the Environment Act 2021 and associated guidance issued by DEFRA. The proposal involves a change of use within an existing building envelope, with no physical extensions, ground disturbance, or loss of green space or semi-natural habitat.
