DEVELOPMENT PROPOSED: Proposed construction of phase 1 of a poultry house to accommodate 16000 free-range chickens for egg production.

AT: Wheatley Farm Four Acre Lane Longridge PR3 2TD

Ribble Valley Borough Council hereby give notice in pursuance of the provisions of the Town and Country Planning Act 1990 that permission **has been refused** for the carrying out of the above development for the following reason(s):

- 1 The applicant has failed to demonstrate a justifiable need for the proposed poultry house and field access track. As such, it is not considered that the development is reasonably necessary for the purposes of agriculture in this instance as per the requirements of Policy DMG2 of the Ribble Valley Core Strategy.
- 2 The proposed poultry house by reason of its size, scale and siting would result in the loss of openness within the site. In addition, the proposed field access track would result in a harmful urbanising impact and erosion of rural landscape. The development would fail to protect, conserve or enhance the landscape and character of the Forest of Bowland National Landscape, contrary to Key Statement EN2 and Policies DMG1 and DMG2 of the Ribble Valley Core Strategy and Paragraph 135 and 189 of the National Planning Policy Framework.
- 3 The application has failed to assess the potential implications for nearby residents with respect to odour. Therefore, it cannot be concluded that the proposed development would be sympathetic to neighbouring land uses and that nearby residential occupants would not be subject to adverse odour issues contrary to Policy DMG1 of the Ribble Valley Core Strategy and Paragraph 135 and 187 of the National Planning Policy Framework.

Note(s)

Notes

Right of Appeal

If you are aggrieved by the decision of your local planning authority to refuse permission for the proposed development or to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.

If you want to appeal against your local planning authority's decision, then you must do so within 6 months of the date of this notice unless the following apply:

- If this is a decision to refuse planning permission for a householder application or a minor commercial application, if you want to appeal against your local planning authority's decision then you must do so within 12 weeks of the date of this notice.
- If this is a decision on a planning application relating to the same or substantially the same land and development as is already the subject of an enforcement notice [reference], if you want to appeal against your local planning authority's decision on your application, then you must do so within 28 days of the date of this notice.
- If an enforcement notice is served relating to the same or substantially the same land and development as in your application and if you want to appeal against your local planning authority's decision on your application, then you must do so within: 28 days of the date of service of the enforcement notice, or within 6 months [12 weeks in the case of a householder appeal] of the date of this notice, whichever period expires earlier.

If someone does not have access to the internet and needs help completing the appeal digitally, they should contact the Planning Inspectorate customer service team on 0303 444 5000 who will provide details of support options available.

The Secretary of State can allow a longer period for giving notice of an appeal but will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.
