The application site extends to approximately 1.2 hectares and is located to the south of Ridding Lane, to the south-west of Whalley village centre. The site comprises a single field.

The site is situated in proximity to several designated heritage assets. Immediately adjacent to the site are Nos. 1, 2, 3 and 4 Abbeycroft, all of which are Grade II listed buildings. To the north lies the north-west gateway to Whalley Abbey, a Grade I listed building and Scheduled Ancient Monument, forming part of the historic remains of the Whalley Cistercian Abbey.

To the north-west is Whalley Viaduct, a Grade II* listed structure which is a prominent feature in local views and the surrounding landscape. Beyond the viaduct lies open countryside. Ridding Lane runs to the north of the site.
