Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Fell flush to ground all three trees:

Two mature pines plus a lesser slender pine plus a larch close to the adjacent property. All trees are in the western corner of the church yard and close to the access path to the church.

Replant with two select standard trees to meet Council requirements in October 2026

An application was made of 2025 to carry out upper canopy pruning following a branch loss onto the main road and buss stop area. In Storm Dave in April 2026 a further branch was ripped out of the canopy and onto the church access path. The branch exceeded 50mm diameter and had a length of 3m and weight of 20kg. Wind exposure is the likely explanation. Removing the trees and planting a mature broad leaf species and a slow growth conifer such as yew will mitigate the risk of harm.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
