Details of the pre-application advice received

The principle of conversion is likely to be considered acceptable provided that the building is of permanent and substantial construction and preserves the openness of the Green Belt. In this respect, it is recommended that the proposed parking area should be accommodated elsewhere within the existing curtilage of Ridings Cottage in order to limit the amount of domestic paraphernalia particularly onto land that is not currently in domestic use. Care should also be taken with respect to impact on privacy, with the proposed dwelling having a direct interface with the existing dwellinghouse and private amenity area at Ridings Cottage.
