Details of the pre-application advice received

The proposed garage is an improvement to the scheme previously refused under application reference 3/2025/0887. However, the size and scale of the building is still considered excessive for a domestic garage outbuilding, and it is unlikely that a structure larger than a standard double garage would be supported. It is therefore advised that the footprint of the garage be reduced to 6m by 6m internally, with the ridge height also reduced to minimise the resultant visual impact.
