The site will be used for a combination of agricultural contracting operations and welding/fabrication activities undertaken by a sole trader. The agricultural contracting element of the business will involve the storage of agricultural machinery and equipment within the proposed new building, including tractors, trailers and associated implements. No processing or industrial activity will take place within the storage building. The welding and fabrication element will be undertaken within the existing buildings and will comprise the fabrication, assembly and repair of metal components.

Machinery and equipment to be used on site will include:

- MIG and TIG welding equipment
- Bench-mounted and handheld grinders
- Metal cutting tools (including saws and plasma cutters)
- Air compressor and associated pneumatic tools
- General hand tools and fabrication equipment

All fabrication activities will take place internally within the building. There will be no external working or fabrication areas.

Ventilation will be provided through the existing building openings and localised extraction units associated with welding equipment, where required. No large-scale industrial ventilation or air conditioning systems are proposed.

The scale of the operation will be modest, with the business operated by a sole trader and generating limited daily vehicle movements. No significant industrial processes or emissions are proposed.
