Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Sycamore. Fell. this tree is in decline and has been for a number of years. We had just been called out to the tree because a large main leader had just snapped out and landed on the building below (thankfully not on the road or pavement!) this has now unbalanced the tree. While we were in the tree we removed an extensive amount of dead wood and found extensive decay pockets.

T2 - Sycamore. 2m crown reduction. the reason for the reduction is to reduce the weight and stress on the limbs that are growing around a decay pocket at the top of the tree.

T3 Sycamore. 2m crown reduction. To reduce weight and sail on the lateral branches additionally due to the reduction in the neighbouring tree I believe this needs the same so it's not exposed to elements it wouldn't normally get, putting it under additional stress especially with its extensive decay pocket lower down.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
