Control Building: the building shall be constructed with built-up insulated trapezoidal metal wall cladding, Euroclad Elite 51 FR30 Quattro Wall System, comprising EC 32-167-1000 external wall reverse profile, 0.7 mm steel sheet, 180 mm rockwool insulation and internal liner sheet. External finish shall be Goosewing Grey, RAL 7038.

The Engineering Stores building will provide additional and purpose-built storage facilities for the entire Johnson Matthey Clitheroe Site, such that process plant spares and engineering equipment can be safely stored. The Control Building (as shown on drawing 6008650-WD-03-28-DR-A-0001-01) is intended to serve as a central control function for the new plants, to reduce in-person operator interaction with the process. The Control Building will also contain shower, toilet, changing and mess facilities, meeting rooms, Permit to Work offices and a Motor Control Centre (MCC).
