There is a timber framed structure, with an asbestos type roof, attached to the dwelling that has fallen into poor condition. This structure is not considered to compliment the listed building and arguably its removal would enhance the site. It is clear to see on site that the structure is only attached to the listed building at the rear, by two purlins to the rear of the property. It is not expected that its removal would cause harm to the fabric of the listed building

The structure is in very poor condition and is not safe, in addition it is built over a culvert. It detracts from the appearance of the listed property and makes maintenance of the culvert problematic.
