To vary the approved plans condition to reflect the extension as constructed, with the external wall positioned approximately 250mm from the boundary with No. 12 Hollies Road rather than the approved 500mm offset. The revised position resulted from practical construction constraints encountered on site and the need to maintain a safe and robust structural connection to the existing dwelling.
