The property 15 Hornby Road (originally 13 Hornby Road until the address was changed to 15 Hornby Road by a previous owner) was extended and then split into two properties 15 and 17 Hornby Road by the applicant and it has been occupied as two entirely self-contained dwellings since 1 September 2001, significantly longer than the ten years required for the change of use from one dwelling to two to have become immune from enforcement action.
