7. Identification of Tree(s) and description of works

T1 – Birch (believed to be Silver Birch)

Carry out a crown reduction of approximately 30–35%, reducing the overall height and lateral spread of the crown by up to approximately 2–2.5 metres, pruning back to suitable secondary growth points and retaining a balanced and natural crown form.

Particular emphasis to be placed on reducing the lateral spread of branches extending over the neighbouring driveway and public footway, with the crown reshaped sympathetically to maintain an appropriate balance.

Crown lift lower branches where necessary to provide approximately 2.5 metres clearance above the public footway and 3 metres above the driveways. Remove any dead, damaged, crossing or defective branches as part of the works.

Reason: The tree has developed a large and spreading crown in a relatively restricted position adjacent to two driveways and the public footway. The proposed works are intended to reduce its overall size and lateral encroachment, provide improved clearance over the neighbouring property and public footway, and maintain the tree at a more appropriate scale for its location whilst retaining the tree and its amenity value.

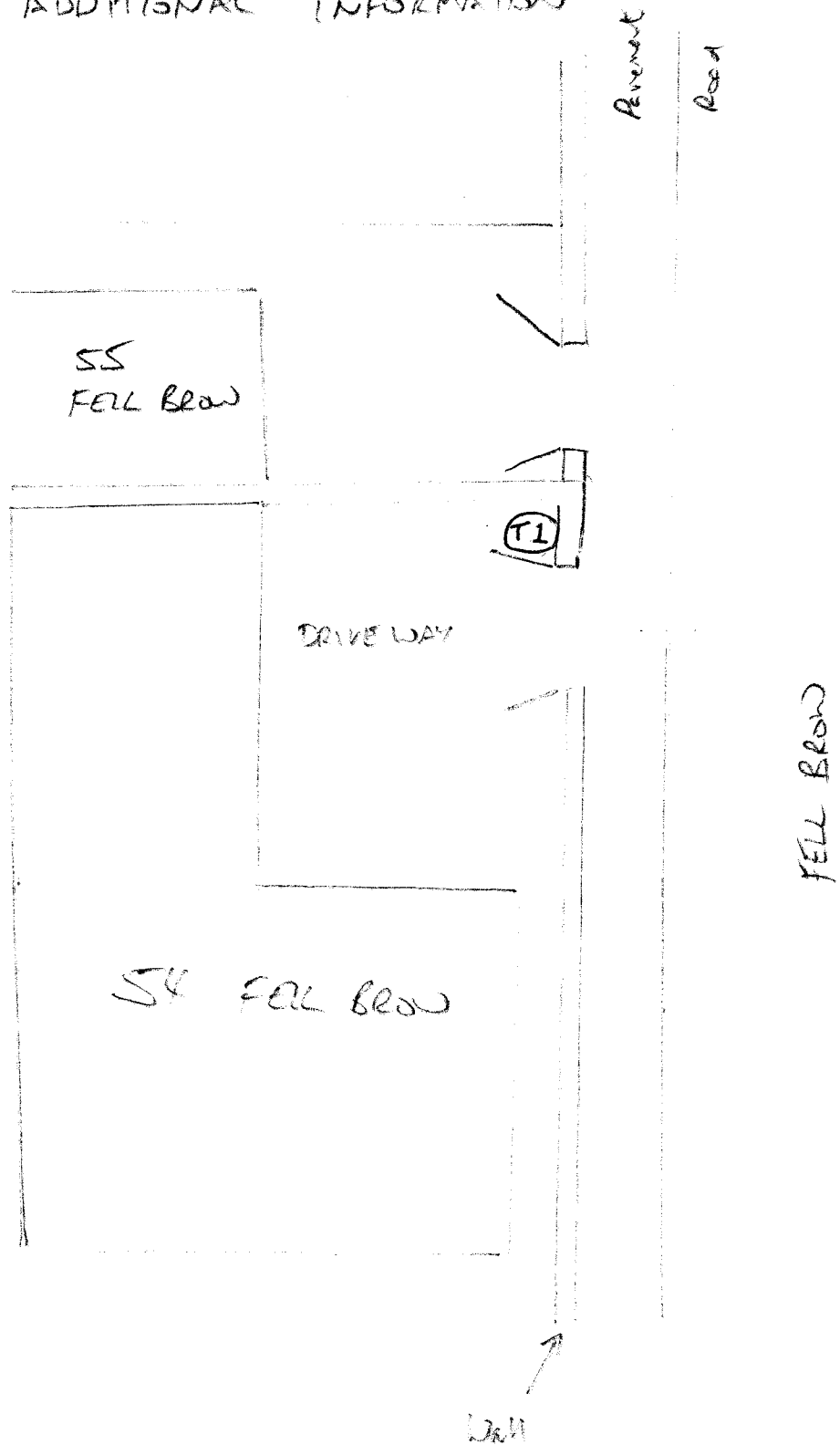
