e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in the same place.

Mature horsechestnut which has had previous permission to prune was inspected by arborist and found to have extensive areas where the bark was hollow or missing, and underlying wood was rotten to a depth of 2 - 3 cm. Also, many fungal fruiting bodies are present and the general condition of the tree is poor. The worst areas are above the first bifurcation, where a main limb of diameter 500mm approx contains an area of 3 square metres of missing bark and water soaked decayed timber. Due to the close proximity of this tree to the dwelling (only 4 metres) the applicant has requested permission to remove the crown, to leave a 6 metre section of standing deadwood.
