We have had two reports carried out. The first report found the trees to be tolerable but a further aerial report did find some to be a risk. I have attached both reports

T3 - Horse Chestnut x 1 Aerial report deemed the tree to be in an unacceptable condition. Option A was to prune the tree and remove the defective branches and option B was to fell the tree. The report details that due to the age of the tree and the risk of further cavities being formed that felling was the best option

G1 Sycamore x 3 Beech x 2 The aerial report classed these as tolerable and can be dealt with by pruning. The Sycamore tree's in particular overhang and residents garden and she has been instrumental in the reports being carried out. She has grave concerns over the damage to her house and garden from the trees, therefore we wish to reduce the sail of the Sycamore trees as much as possible to reduce any further infringement on the house in question
