There has already been an application approved for trees in this area but not all the trees were covered by the original application hence the second application. The first application is under 3/2019/0344 and the felling of T3 Horse Chestnut has been approved and also work to G1 Sycamore tree. In the report dated Nov 18, G1 relates to a group of trees; 3 no. Sycamore and 2 no. Beech, however the application approves work to reduce Sycamore within G1. Does this only relate to one Sycamore? If so which one? and what about the others and the two Beech trees. I would like work to these trees to also be approved in this application
