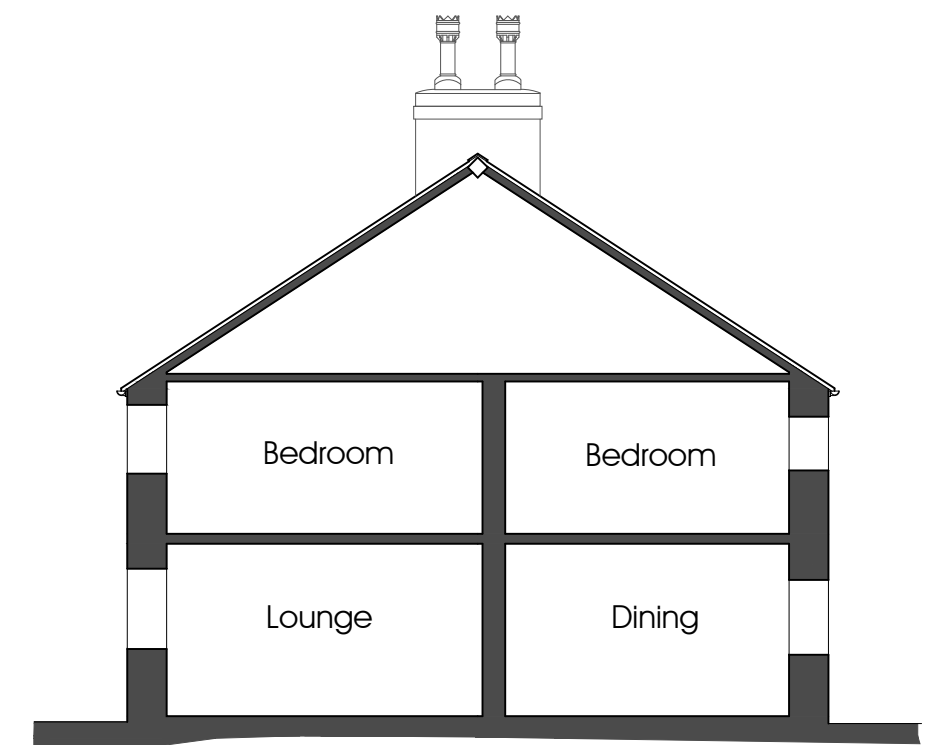
Ground Floor Plan - Building 1



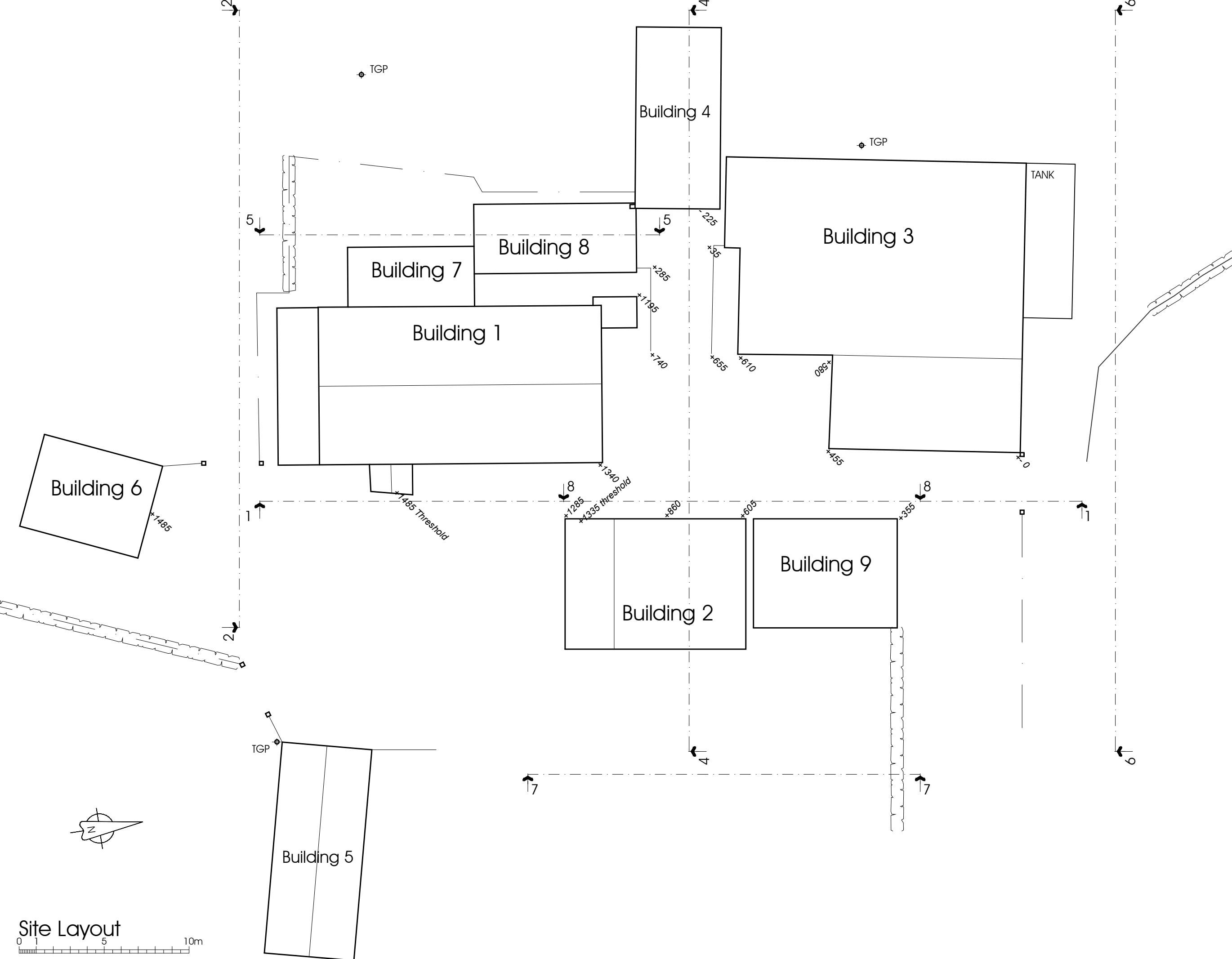
