Please find attached an overlay of Public Right of Way 3-36-FP22 within the proposed site.

As you can see the proposed extension narrows the existing footpath and the proposed new garden fences appear to reduce the width of the footpath to a very narrow gap.

The current width of Public Right of Way 3-36-FP22 is 4ft wide and as such Public rights of Way object to the proposed extension as it would be an obstruction if the planning application was approved in its current form. If the application is approved the landowner would be subject to enforcement proceedings due to the obstruction.
